

The Forum for Awareness and Youth Activity (FAYA) Nepal is an multisectoral Non-government, Nonpolitical and Non-profit making organization working in Nepal based in Dhangadhi Kailali, Sudurpashchim Province. After its establishment in 1995 it focused on empowering youths and their networks to fight many social evils. In 2004, it started leading and participating in various human rights networks/alliances, with a public policy agenda that included advocating for equal pay, safe rehabilitation of freed Kamaiya, and strengthening women's networks. FAYA has contributed to numerous rights-based social movements over the years, such as the Kamaiya and women's rights movements. In 2009, FAYA adopted four foundational themes and three cross-cutting themes to consolidate its priorities and gain recognition as a leading rights-based development organization. In 2014, FAYA further consolidate its strategy, focusing on promoting food security, sustainable livelihoods, and supporting citizen initiatives for quality public services and local governance, as well as

addressing violence against women.

SUAAHARA-II

Good Nutrition Program

The SUAAHARA project commenced in 2016 with a primary focus on enhancing the comprehensive care and nutrition for children under the age of 2 and pregnant or lactating mothers. This initiative has been executed across 13 local governments (LGs) within the Kailali district. Its core objectives encompass providing nutritional assistance to pregnant and lactating mothers as well as 2-year-old children, promoting sustainable agricultural practices and animal husbandry, delivering essential healthcare services during critical life stages, fostering improved governance within healthcare services through the use of community scorecards, and spearheading initiatives related to clean water and sanitation. The project's scheduled completion date was September 2022.

Program Objectives:

Enhance children's accessibility to adequate nutrition, dietary support, and healthcare services to address malnutrition in children aged under five.

Key Intervention:

- 1. Conduct outreach activities to identify 1000-day households and offer informative and counseling services through a combination of phone consultations and in-home visits. These services encompass integrated nutrition guidance, handwashing education, support for nutritious food production, and initiatives to promote behavior change.
- Regular assistance to enhance health and nutrition services through the outreach clinic al LG level.
- Regular support to the municipality in conducting nutrition and health related programs.

Climate Canage & Reproductive Health

The impacts of climate change on women's Project Objectives: reproductive health are multifaceted. During disasters, restricted access to services and infrastructure damage limit mobility. The added workload on women, resulting from crop failures and water and food scarcity, increases physical strain and stress. Rising temperatures, uncertainty, and risks directly threaten both the psychosocial and physical well-being of women, including their reproductive health.

Given this context, FAYA Nepal collaborated with Ipass Nepal to launch the SRHR agendas at the LG level. Climate Justice, Gender, and Sexual and Reproductive Health and Right (SRHR) project in Kailali district. The project aims to support and empower local representatives, local government officials and community stakeholders by integrating gender and SRHR considerations into climate change adaptation policies and plans, using an intersectional approach to foster the development of climate-resilient communities. This project has been implemented Dhangadhi Sub metropolis and Chure rural municipality focusing in ward no 15 and 17 of Dhangadhi sub metropolis and ward no 1 and 4 of Chure rural municipality of Kailali district.

Understand climate change impacts on SRHR for women and girls, emphasizing vulnerabilities linked to gender, socioeconomic factors, and their intersections.

Identify local climate adaptation efforts, address gaps, and offer technical assistance, including SRHR integration, to local stakeholders.

ACHIEVEMENTS 1

Action Item:

Developed and disseminated LAPA for Chure rural municipality and ward 15 and 17 of Dhangadhi sub metropolis of Kailali district. The LAPA is enriched with a focus on gender-sensitive concerns and sexual and reproductive health and rights (SRHR). Chure Rural Municipality is currently putting the LAPA into action as part of its annual plan for fiscal year 080/081.

ACHIEVEMENTS 2

Action Item: Trainings Twelve Nursing Staff trained on Implant and Medical Abortion Service (6 Implant and 6 MA service) of Chure RM and Dhangadhi metropolis ward 15 and 17. This initiative led to the establishment of 10 new service sites. (8 site in Chure and 2 site in Dhangadhi), marking their initial foray into service provision.

ACHIEVEMENTS 3

Action Item: Training Health Facility Operation Management Committee (HFOMC) representing Chure Ward 1 and 3, as well as Dhangadhi Sub-Metropolis Ward 15 and 17, have been provided with the necessary knowledge about CC and SRHR. This knowledge equips them to advocate for SRHR financing during the local planning process.

ACHIEVEMENTS 4

Action Item: Training A total of 131 young individuals from Chure Rural Municipality and Dhangadhi Metropolis have received training on Sexual and Reproductive Health and Rights (SRHR). the trained youths disseminating their knowledge and information at community level through peer to peer approach.

ACHIEVEMENTS 5

Action Item: Field Study

The field study on Gender, Climate Justice, and SRHR has been successfully concluded. This study serves as a valuable resource for comprehending the connections between gender, CC, and SRHR. Its findings are expected to have a significant impact on the development of future policies and programs.

CLIMATE JUSTICE, GENDER δ **SRHR**

Achievements

ACHIEVEMENTS 6

Action Item: Volunteering Twenty-seven volunteers, identified as Natural Leaders (NL), were trained and empowered to address climate change (CC) and sexual and reproductive health and rights (SRHR). These NLs were then mobilized at the community level to spread awareness and knowledge about the effects of CC and SRHR. In total, they successfully reached and educated 505 community members on these crucial subjects.

ACHIEVEMENTS 7

Action Item: Construction The construction of the ORC structure has brought significant benefits to 140 households in the Khailad community of Chure Rural Municipality. The Sayal Community Health Unit (CHU) consistently delivers ORC services to the Khailad community, with an average of 25-35 individuals seeking these services every month.

ACHIEVEMENTS 8

Action Item: Intensive support

A total of 130 households, with a particular focus on women, have successfully eliminated smoke exposure by adopting improved cooking stoves. Out of these, 98 households have experienced these benefits in Chure Rural Municipality, while 32 households reside in Dhangadhi Sub-Metropolis.

COMMUNITY MOBILIZATION FOR COVID VACCINATION

Covid-19 Vaccination

COVID-19 is a highly contagious respiratory illness caused by the novel coronavirus SARS-CoV-2. It emerged in Wuhan, China, in late 2019 and quickly became a global pandemic. Nepal also faced considerable challenges during this time, particularly in its healthcare system. Some regions experienced overwhelmed hospitals, leading to shortages of beds, oxygen, and essential medical supplies. In early 2021, Nepal launched a vaccination campaign with COVAX-provided vaccines and others from different sources, aiming to immunize a large portion of the population to mitigate the virus's impact. Vaccination progress varies across regions, with wealthier urban areas achieving nearly 100% coverage, while remote regions are falling behind. In Kailali district, out of an estimated population of 967,728, only 70.5% have received the first vaccine dose, and 72.1% have completed the full vaccination regimen (two doses of COVISHEID/AstraZeneca, Vero cell, Pfizer, Moderna, or a single dose of Janssen vaccine). Additionally, just 20.7% have received a booster dose as of May 20, 2022. In response to this situation, FAYA Nepal, in collaboration with GIZ, has initiated the "Community Mobilization for COVID-19 Vaccination Program" enhance community engagement and reach underserved groups by partnering with local governments, the healthcare system, and other stakeholders.

The project began on July 25, 2022, and is set to conclude on December 10, 2022. Additionally, the project's focus areas include the Dhangadhi metropolis, as well as the municipalities of Godavari, Gauriganga, Ghodagodi, along with the Chure and Kailari rural municipalities.

The objective of the project is to intensify tested activities to inform and mobilize communities on the COVID-19 vaccination campaign by engaging Community mobilizers and Female Community Health Volunteers (FCHVs) in the district of Kailali and by doing so sustain and increase immunization coverage of COVID-19 vaccine of the estimated target population (5 years and older) of around 870,000 of 967,728.

COMMUNITY MOBILIZATION FOR COVID VACCINATION

Achievements

ACHIEVEMENTS 1

Orientation

Action Item: A large number of community leaders (Bhalmansa and Chiragis) and public and private school teachers were motivated and mobilized under this campaign. Motivated teachers became assistants in school vaccination camps and motivated students to get vaccinated. Vaccination Coordinating Committee (VCC) in 5 municipalities became active after meeting and orientation.

Key Intervention:

- 1. FCHV Orientation and mobilization.
- 2. Mobile Vaccination Camp
- 3. Supply support to PoE

ACHIEVEMENTS 2

Mobilization

Action Item: The mobilization of 578 FCHVs across 42 health facilities in Kailali district led to the identification of 54,512 unvaccinated individuals within the 6 local levels of the district and motivated them for vaccination, marking a significant achievement in healthcare outreach.

Vaccination

Action Item: An accomplishment was made by vaccinating 11,988 individuals from the identified unvaccinated population through mobile camps, while the remaining individuals were successfully directed to vaccination sites at health facilities.

STRENGTHENING SAFE ABORTION ECO SYSTEM NEPAL

Sexual and Reproductive Health

Safe abortion is legally permitted in Nepal under specific conditions since 2059 B.S. The government estimated the provision of safe abortion services in 75 districts, with approximately 1000 safe abortion service sites. Nepal recognizes health as a fundamental right and considers safe abortion and its treatment for complications as essential elements of healthcare. The country has enacted the Safe Motherhood and Reproductive Health Right Act 2075 and Regulation 2077, as well as the Public Health Service Act 2075 and Regulation 2077, to guide the provision of safe abortion. The Constitution of Nepal 2072 also declares health as a fundamental right.

However, despite these efforts, unwanted pregnancies and preventable deaths resulting from pregnancy, abortion, and its complications persist. This is due to the stigma surrounding abortion in our country, leading women and girls to choose unsafe but seemingly "easier" methods rather than legal and safe options.

FAYA Nepal, in collaboration with Ipas Nepal, has been working to strengthen the abortion ecosystem in Nepal by raising awareness, advocating for change, and enhancing the healthcare system in Dhangadhi Sub Metropolitan City and Chure RM of Kailali district.

Project Objective Promoting sexual and reproductive health and rights, enhancing safe abortion service programs, and strengthening health care systems.

STRENGTHENING SAFE ABORTION ECO SYSTEM NEPAL

Achievements

ACHIEVEMENTS 1

Action Item: Advocacy Sahajpur HP and Nigali HP have implemented corrective action at their health facilities following the interface dialogue and developed an action plan. (Rearranged the MA service room, maintenance of confidentiality measures, hoarding board mentioning free SAS etc.)

ACHIEVEMENTS 2

Action Item: Training A total of 50 adolescents have received training on sexual and reproductive health, and they are now actively mobilizing within their respective communities to raise as a local capacity.

ACHIEVEMENTS 3

Action Item: Intensive support Specialist service was provided to a total of 206 individuals through health Camp. Among them, 165 were females who received gynecologist services. During the camp, 20 females were recommended to undergo a Pap test due to suspicion. Out of the 20, three females were identified as suspected cases and were referred for further medical examination.

ACHIEVEMENTS 4

Action Item: Intensive support

The total of 30 poor and pro poor groups (focusing in female) of both Dhangadhi and Chure were started their small business and other livelihood initiative with support of seed money (NPR 35000/person).

Achievements

ACHIEVEMENTS 5

Action Item: Support

Renovation and equipment support to the service site in Ward No. 15 and 17 of Dhangadhi Sub-Metropolitan City, safe motherhood and implant services have commenced.

ACHIEVEMENTS 6

Action Item: Material support The local level (Ward No. 15 and 17) has received material support for their rescue efforts, which has greatly benefited them and inspired plans to acquire additional materials from the upcoming budgeting and planning phase.

ACHIEVEMENTS 7

Action Item: Training The local level has had 24 volunteers who possess first aid, search and rescue skills, thereby enhancing their local capacity to respond effectively during emergency situation.

UNFPA COUNTRY PROGRAM

Sexual and Reproductive Health

Nepal aspires to achieve middle-income status by 2030, focusing on improving sectors like health and education, which have already shown significant progress. Despite these advancements, poverty persists at a rate of 21.6 percent, with certain groups experiencing high levels of deprivation. The nation is marked by substantial diversity, boasting 125 caste/ethnic groups, and notable disparities in social and economic indicators exist.

The eighth UNFPA country program (June 2022- 16 June 2023) focused on sexual and reproductive health, gender equality and reproductive rights, population dynamics and youth empowerment. The country program evaluation described the program as "well aligned with relevant national legislation, policies, strategies and program". Key achievements included: (a) influencing major policies, including the constitution and the Population Policy, from a rights perspective; (b) interventions to improve access to family planning services for vulnerable women and the introduction of midwifery education; (c) prevention of child marriage by empowering adolescent girls; (d) dissemination of the 2011 census results; (e) increased participation of youth in policy making; and (f) emergency preparedness and response.

The objective of the program is to accelerate the achievement of universal access to sexual and reproductive health and reproductive rights, with a focus on reducing preventable maternal deaths, unmet need for family planning, genderbased violence, child marriage and other harmful practices

Achievements

ACHIEVEMENTS 1

Action Item: Humanitarian action

The MoSD consistently provided assistance to facilitate protection cluster meetings throughout the year. During the cluster meeting held on September 16, 2023, it was decided to respond to the Dracula flood and landslide. Following the meeting's conclusion, the FAYA promptly delivered 150 dignity kits, 50 Kishori kits, and six sets of RH kits (comprising 4 sets of Kit 6B, 1 set of Kit 7, and 2 sets of Kit 8) to health posts, hospitals, and areas with a significant population of women and girls in need.

ACHIEVEMENTS 2

Action Item: Policy advocacy The successful advocacy efforts regarding Gender Biased Sex Selection (GBSS) in collaboration with Patan Municipality. During a workshop, it was decided to develop a five-year Action Plan for Patan Municipality, specifically aimed at addressing GBSS. Subsequently, this comprehensive five-year action plan to combat GBSS has been officially put into effect.

These drafted policies have been formally submitted to the MoSD and the Youth Council for their review, and they are currently in the official approval process.

Action Item: Girl conference An achievement to highlight is the support provided by the MoSD in organizing the 2022 Province Adolescent Girl Conference. This conference brought together over 100 adolescent girls, including those who were married, unmarried, attending school, or out of school, from nine district for a two-day event. During the conference, the Dhangadhi Declaration, consisting of 15 strategic points, was formulated and presented to the MoSD. Subsequently, the MoSD officially committed to advancing the objectives outlined in this declaration.

ACHIEVEMENTS 6

Action Item: Policy advocacy

An achievement to highlight is the support provided by the Ministry of Internal Affairs and Law (MoIAL) in facilitating a workshop to review the Provincial Disaster Management Plan (DMP). This workshop brought together high-ranking officials from the province for a two-day gathering in Thakurdwara, Bardiya. During the workshop, a comprehensive discussion on the DMP was held, and key areas requiring revision were identified. The MoIAL took note of these revision proposals, which are currently in the process of being addressed.

ENHANCING CHOLERA CONTROL IN NEPAL (ECHO-N)

Health and WASH

Nepal is characterized by endemic cholera and the potential for significant outbreaks. Although 93 percent of households in Nepal utilize improved sources of drinking water, and 72 percent have access to improved sanitation facilities, open defecation persists in various regions. The nation faces a heightened risk of cholera outbreaks due to several factors, including the continual rise in urban population density, coupled with an inadequate supply of safe drinking water and improved sanitation. Furthermore, Nepal ranks among the top 5 countries most vulnerable to the effects of climate change.

Kailali district, in particular, experiences flooding and landslides during the rainy season in every year, often leading to the deterioration of already fragile water and sanitation infrastructure. Additionally, limited diagnosis and surveillance reporting contribute to the likelihood of cholera outbreaks, which can be challenging to prevent and control.

In response to these pressing issues, FAYA
Nepal, in partnership with Good Neighbor
International (GNI) and with financial
support from International Vaccination
Institute (IVI), has initiated the ECHO-N
project in Kailali district. This project focuses
on areas such as Godavari and Tikapur
municipalities and includes upgrades to Seti
Provincial Hospitals lab in Dhangadhi.

The primary objective of the ECHO-N project is to strengthen Nepal's capability to identify, address, and preempt cholera outbreaks.



IMPROVING HEALTH SEEKING BEHAVIOR OF MOTHERS AND CHILDREN-IHSBMC

Maternal and Child Health

Enhancing the health behavior of mothers and children represents a crucial initiative aimed at addressing disparities in maternal and child health, ultimately securing the wellbeing of future generations. The importance of maternal and child health is a global priority. It is essential to ensure that mothers receive adequate care throughout their pregnancies and childbirth, while children receive proper nutrition and healthcare during their formative years. This is vital for reducing mortality rates and fostering healthy development. Despite notable progress in recent times, maternal and child mortality and morbidity rates remain alarmingly high in various parts of the world, particularly in low- and middle-income nations like Nepal. For instance, Nepal records a mortality rate (MR) of 151 per 100,000 live births, while the Sudurpashchim province reports an MR of 130 per 100,000 live births according to NDHS-2022.

FAYA Nepal, in collaboration with AMDA-MINDS Nepal Office, is actively implementing the "Improving Health Seeking Behavior of Mothers and Children (IHSBMC)" project in Chure rural municipality. This project receives financial support from the Ministry of Federal Affairs of Japan (MoFA).

Objective:

- 1- MCH health seeking behavior is improved among community people in the targeted area.
- 2- Safe deliveries are promoted through the public health services in Chure RM.

Key Intervention:

- 1. FCHV mobilization.
- 2. Pregnant Women group orientation.
- 3. Baseline survey for the project.
- 4. Technical support for HMG meeting.
- 5. Technical support EPI/ORC
- 6. Home visit of Pregnant Women.
- 7. Construction of Health facility building.

IMPROVING HEALTH SEEKING BEHAVIOR OF MOTHERS AND CHILDREN-IHSBMC

Achievements

ACHIEVEMENTS 1

Action Item: Orientation A total of 120 pregnant women, 35 husband, 23 In-Laws and 116 family members were informed about various aspects of safe motherhood and role of husband, in-laws and family members during the period of pregnancy, delivery and postpartum period.

ACHIEVEMENTS 2

Action Item: Counselling visit A total of 173 pregnant women (new visit=133 and re-visit= 40) were followed up by CHM at their home and assessed their status and provided health education. Out of 173 pregnant women 72 were visited health facilities for ANC (68 visited as per protocol) and 15 pregnant women were referred to health facilities for ANC and other services {for ANC=11 and for others = 3}. And 89% of pregnant women were taking iron tablets regularly.

ACHIEVEMENTS 3

Action Item: Health education During the reporting period, we successfully educated 1,164 mothers by conducting 58 HMG meetings and reached out to 610 individuals through 30 EPI/ORC sessions. Our achievement lies in imparting knowledge regarding diverse aspects of safe motherhood, including the crucial roles of husbands, in-laws, and other family members during pregnancy, delivery, and the postpartum period.

ACHIEVEMENTS 4

Action Item: Construction

We have made significant progress in the construction of the health post building in Chure rural municipality. The ongoing construction work is expected to be completed by the end of February 2023, marking a substantial achievement in our efforts to improve healthcare infrastructure in the area.

Emergency Preparedness

Local organizations' emergency preparedness is crucial due to their swift response and intimate knowledge of the local terrain, ensuring effective aid delivery. Their strong community ties, built on trust and cultural awareness, enhance acceptance during crises. These organizations optimize resources, utilize local skills, and minimize risks by identifying vulnerable groups. Coordinating seamlessly with authorities and involving communities actively creates a robust emergency response system. Additionally, their focus on building capacity ensures sustainable resilience. Recognizing this, HelpAge International collaborates with FAYA through the SHAPE project to bolster local capacities, aiding swift disaster recovery.

The SHAPE (Strategic Humanitarian Assessment and Participatory Empowerment) is an in-depth program of support for the organization to strengthen their capacity to determine, influence, and deliver humanitarian preparedness and response by maintaining structural and programmatic levels.

It is a process of capacity strengthening using an internal change process. SHAPE was developed by several organizations under the "Shifting the Power".

The main objective of this project is to empower local organizations by enhancing their ability to deliver age-inclusive humanitarian preparedness and response.




